

VINYL DECK

PARAGON PLASTICS INC.

Paragon Plastics Inc. (herein "Manufacturer") warrants that each deck product will not rot, decay, split, check, splinter or suffer termite damage, abnormal weathering or abnormal discoloration under conditions of normal use and service. The Manufacture warrants only those products manufactured by it and this warranty extends only to the original purchaser. The warranty provided herein is expressly conditioned upon the use of the product in connection with a residential structure and its installation in accordance with Manufacturer's written guidelines.

EXCLUSIONS:

Paragon Plastics Inc. shall not be liable for and this warranty does not apply to any failure, defect or damage resulting from or connected with the following:

- A. Defects not caused by Manufacturer (for example, but not limited to: accidents, misuse, improper applications, installation or alterations contrary to industry or Manufacturer standards).
- B. Deck that has been painted or had its surface exposed to other than approved chemicals.
- C. Deck product subject to impact of foreign objects, tornado, hurricane, flood, other violent storms, fire, air pollutants, normal weathering of surfaces, abnormal discoloration due to improper maintenance, or acts of God.
- D. Hardware, gate or accessory items; installation on these products or defects caused by their installation.
- E. Any consequential or incidental damages.

OTHER CONSIDERATIONS:

Manufacturer and its employees are not qualified to approve, recommend or advise as to the suitability of its product for all possible end use and applications. Each purchaser of deck products is solely responsible for determining the effectiveness, suitability and safety of any particular use or application of the product. Local Code authority and fire marshal's office should be consulted as to its intended uses. Paragon Plastics Inc. reserves the right to discontinue or change any products as manufactured. If the products covered by this Limited Warrant are not available, Paragon Plastics Inc. shall have the right to substitute a product that, in its sole discretion, is of equal quality or value. This Limited Warranty does not include any costs incurred in the removal or replacement, reassembly, installation, or reinstallation of the products nor does it include any costs and expenses incurred in returning the products to the factory, if return is required by Paragon Plastics Inc.

REGISTRATION OF WARRANTY:

The attached warranty registration card must be completed, signed by the original purchaser, and the installing contractor and returned to Paragon Plastics Inc. within (30) days after purchase of products in order for *purchaser* to be eligible for coverage under this warranty.

WARRANTY:

The warranty period will be pro-rated as follows: During the first (10) years after the date of original purchase date of the product Paragon Plastics Inc., will at its option, replace the section or part of the product, or refund the prevailing cost of the section or part of the product in your geographical area at the time of replacement or the original pro-rated purchase price, which ever shall be less. Beginning in the eleventh (11th) year through the twenty eight (28) year, Paragon Plastics Inc.'s responsibility will decrease by 5% per year until the end of the twenty eight (28) year when Paragon Plastics Inc.'s responsibility will be limited to 10% of the original cost of the material based on Paragon Plastics Inc.'s list price at the date of purchase for the remaining period. The warranty shall not be extended by any repairs or replacement.

CLAIMS AND REMEDIES:

A claim under this warranty must be reported in writing with proof of purchase, to Paragon Plastics Inc. within thirty (30) days of the date that the defect is first discovered or reasonably could be discovered. A reasonable time should be allowed for inspection purposes, or at Manufacturer's option, freight to Manufacturer's premises to be prepaid by the purchaser for examination of the alleged defective product. Manufacturer shall be the sole judge of whether or not the product is defective and if the defect is due to manufacturing defects. This warranty does not cover the cost of installation or fabrication of any defective products or the cost of installation of any replacement product furnished under the terms of warranty. The foregoing express warranty excludes all other warranties, express or written, made by Manufacturer or any agent thereof, which is not contained or authorized herein, will be recognized by Manufacturer for consumer purchases, implied warranties or merchantability and fitness of a particular purpose are not excluded. By acceptance of the use of this product, purchaser agrees, the Manufacturer liability and the purchaser's exclusive remedy for the breach of any warranty shall be limited in all events to replacement of any section or part of this product which shall be returned to Manufacturer and which is found to be defective.

This warranty may not be altered or amended except in written instrument signed by Manufacturer or subsequent owner. No dealer or other person or entity is authorized by the Manufacturer to make statements or representations regarding the performance of Paragon Plastics Inc. Deck Products except as contained in this Warranty, and the Manufacturer shall not be bound by any such statements other than those contained herein.

THE FOREGOING WARRANTY IS EXCLUSIVE AND IN LIEU OF ANY AND ALL OTHER APPLICABLE WARRANTIES, EXPRESS OR IMPLIED, INCLUDING WITHOUT LIMITATION, AND IMPLIED WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE.

Some states do not permit limitation on the duration of implied *warranties* or exclusions or limitations of incidental or consequential damages. This warranty gives you specific legal rights. You may have other rights which will vary from state to state.

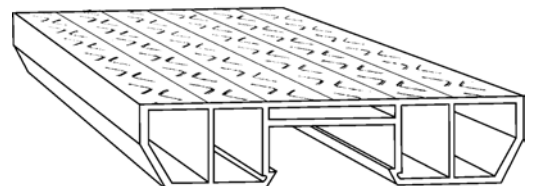
